CIRCULAR

On the request of Seed producers the permission for the Advance tagging of Wheat, Barley & Gram Certified Seed is permitted for Rabi 2013-14 produce till 30th Sept. 2014, subject to following conditions.

1. All the seed producers shall ensure to submit the intake list of raw seed procured/received from seed growers as per expected production, immediate after the procurement, but not later than 3 days of cutoff date. If list is submitted after the cutoff date it will not be acceptable for grading,
2. All the officer Incharges shall ensure the physical verification of the stock at the threshing floors/ processing plant/godowns as per procedure laid down by head office prior to start of processing of the certified seed. This P.V. report should be forwarded to head office immediately otherwise unit incharge will be held responsible.
3. An undertaking from the concerned seed producer shall be taken in writing on Rs.10/ non judicial stamp paper that "the advance packed certified seed shall be stored properly and shall not be sold and/or moved to other place without prior approval of certification agency. If the advance tagged seed lot is declared substandard by seed testing laboratory the tags of such lot shall be returned back immediately", in case all tags of substandard seed lot is not returned back, advance tagging will be stopped till the return of all tags. If violation of this condition is found/observed, the producer shall be penalized like withdrawal of permission of advance tagging and cancellation of certificate of the concerned seed lot.
4. Moisture percentage found in limit shall only be permitted for the advance packing.
5. The concerned seed producer shall intimate the packing size and quantity of the seed of particular crop/variety to be packed, including. Minikit/Demonstration if any, before advance packing in the normal size of packing. Any deviation in packing size/packing material shall be intimated to this office and proper approval of the same shall be obtained from this office.
6. All outstanding payments shall be cleared by the concerned seed producers together with advance before start of grading.
7. The cutoff date fixed in calendar of operation should be adhered strictly.
8. The permission of advance tagging cannot be accorded to the production agencies who has found defaulter in returning tags of sub-standard seed lots of Kharif - 2013 and Minikit / Repacked seed lots.
